There is hereby appropriated from the 2022 Sheriff's Special Projects Fund (#3400) \$1,879.83 for the following designated expenditures:

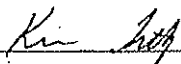
- \$ 1,879.83 to GL# 3400-0400-3003 (Sheriff's Projects - Computer Services)

There is hereby appropriated from the 2022 County Jail Fund (#3401) \$4,121.32 the following designated expenditures:

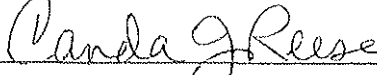
- \$ 5.00 to GL# 3401-0418-0199 (Jail: Transport for Prisoners)
