

BE IT RESOLVED BY THE QUORUM COURT OF THE COUNTY OF BAXTER, STATE OF ARKANSAS, THAT:


WHEREAS, a member of the Norfolk Fire Protection District Board of Commissioners, Earl Olsen, is unable to complete his three-year term on the Board.


