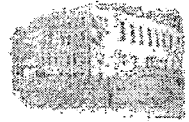

NOW on this 16th day of May, 2024, a day on which this Court deems to be in session, comes on for consideration the selling of 2018 Mack Dump Truck for salvage value by the Baxter County Road and Bridge Department. From the records of said solicitations of bids, the Court finds the following:

1. That all potential bidders engaged in purchasing a salvage 2018 Mack Dump Truck, who have applied in the office of the County Judge, an ex-officio purchasing official for Baxter County, stating a desire to be placed on a list of eligible bidders in that class of commodities, have been supplied with ample specifications.
2. That on the 17th day of April, 2024, said purchasing officer advertised for bid the sale of a salvaged 2018 Mack Dump Truck by placing a legal notice in the Baxter Bulletin, a newspaper having general circulation in Baxter County, Arkansas. The notice of publication and a copy of said specifications are hereto attached as Exhibits A and B respectively.
3. On May 15, 2024, Pratts Auto Salvage & Sales, Inc. delivered or caused to be delivered their bid at the time and place appointed in the bid notice. No other bids were received.
