**BE IT ENACTED BY THE QUORUM COURT OF BAXTER COUNTY, STATE OF ARKANSAS,
AN ORDINANCE TO BE ENTITLED:**

**AN ORDINANCE APPROPRIATING FUNDS IN THE AMOUNT OF \$83,000.00 FROM THE
JAIL MAINTENANCE & OPERATION (3401) FUND INTO THE JAIL MAINTENANCE &
OPERATION 2025 BUDGET, AND; APPROPRIATING FUNDS IN THE AMOUNT OF
\$33,000.00 FROM THE SPECIAL JAIL FEES FUND (3017) AND \$10,000.00 FROM THE
COUNTY DETENTION FACILITY FUND (3018) INTO THE JAIL MAINTENANCE &
OPERATION 2025 BUDGET.**

Article 1. Affirmation: The Sheriff's Office is requesting a new allocation of funds within
the 2025 budget for the purpose of appropriate assignment of expenditures.

Article 2. Designation: There are sufficient funds available for said transfers.


Article 3. Appropriation: The County Treasurer is authorized to transfer \$33,000.00
from Special Jail Fees Fund (3017) and \$10,000.00 from County Detention Facility Fund
(3018) into the Jail Maintenance & Operation Fund (3401).

The Quorum Court authorizes the Clerk's Office to make the following appropriations
into the designated line items:

\$33,000.00 to GL #3401-0418-4005 (Purchase of Vehicles)
\$10,000.00 to GL #3401-0418-2002 (Small Equip)
\$55,000.00 to GL #3401-0418-4005 (Purchase of Vehicles)
\$ 5,000.00 to GL #3401-0418-3009 (Other Prof Svcs)
\$23,000.00 to GL# 3401-0418-4004 (Mach & Equip)

Article 4. Effective Date: This appropriation ordinance shall be effective immediately
upon its passage by the quorum court.


