- 5. It was determined to be in the best interest of Baxter County to accept the bids submitted by both Atlas Asphalt Inc. and Dilbeck Excavation. Said acceptance to Atlas Asphalt Inc. is hereto attached as Exhibit E and said acceptance to Dilbeck Excavation, Inc. is hereto attached as Exhibit F. The Clerk of this Court shall docket this copy and cause a copy of this order and supporting documents to remain on file for public inspection.






