- 5. It was determined to be in the best interest of Baxter County to accept the bid submitted by Mountain Home Concrete. Said acceptance is hereto attached as Exhibit E.

IT IS THEREFORE the order of this Court that the bid from Mountain Home Concrete is hereby accepted and the Clerk of this Court shall docket this copy and cause a copy of this order and supporting documents to remain on file for public inspection.




