


IN THE COUNTY COURT OF BAXTER COUNTY, ARKANSAS

IN THE MATTER OF THE PURCHASE
OF BULK ICE CONTROL SALT FOR THE
BAXTER COUNTY ROAD & BRIDGE DEPARTMENT

COURT ORDER NO. 2025 - 35

NOW on this 22nd day of April, 2025, a day on which this Court deems to be in session, comes on for consideration the purchase of Bulk Ice Control Salt to be used by the Baxter County Road & Bridge Department. From the records of said solicitations of bids, the Court finds the following:

1. That all potential bidders engaged in selling bulk ice control salt, who have applied in the office of the County Judge, an ex-officio purchasing official for Baxter County, stating a desire to be placed on a list of eligible bidders in that class of commodities, have been supplied with ample specifications.
 2. That on the 26th day of March, 2025, said purchasing officer advertised for bid the purchase of Ice Control Salt by placing a legal notice in the Baxter Bulletin, a newspaper having general circulation in Baxter County, Arkansas. The notice of publication and a copy of said specifications are hereto attached as Exhibits A and B respectively.
 3. On April 21st, 2025, Oakley Fertilizer, Inc. and Central Salt, LLC delivered or caused to be delivered their bids at the time and place appointed in the bid notice. No other bids were received.
 4. At 9:00 a.m. on the 22nd day of April, 2025, said bids were opened and publicly read in the office of the County Judge. Oakley Fertilizer, Inc. submitted a bid as shown by Exhibit C and Central Salt, LLC submitted a bid as shown by Exhibit D.
 5. It was determined to be in the best interest of Baxter County to accept the bid submitted by Oakley Fertilizer, Inc. and the bid submitted by Central Salt LLC. Said acceptance for Oakley Fertilizer, Inc is hereto attached as Exhibit E and said acceptance for Central Salt, LLC is hereto attached as Exhibit F.
- IT IS THEREFORE the order of this Court that the bids from Oakley Fertilizer, Inc. and Central Salt, LLC are hereby approved and accepted. The Clerk of this Court shall docket this copy and cause a copy of this order and supporting documents to remain on file for public inspection.
