



BAXTER COUNTY ROAD & BRIDGE DEPARTMENT


COURT ORDER NO. 2026 - 19

NOW, on this 18th day of February, 2026, a day on which this Court deems to be in session, comes on for consideration the purchase of Asphaltic Concrete Hot Mix Type 3 and Asphaltic Concrete Cold Plant Mix with Cutback Asphalt to be used by the Baxter County Road & Bridge Department. From the records of said solicitations of bids, the Court finds the following:

1. That all potential bidders engaged in selling asphaltic concrete hot/cold mix, who have applied in the office of the County Judge, an ex-officio purchasing official for Baxter County, stating a desire to be placed on a list of eligible bidders in that class of commodities have been supplied with ample specifications.
 2. That on the 14th day of January, 2026, said purchasing officer advertised for bid hot/cold mix by placing a legal notice in The Baxter Bulletin, a newspaper having general circulation in Baxter County, Arkansas. The notice of publication and a copy of said specifications are hereto attached as Exhibits A and B respectively.
 3. On February 17, 2026, Atlas Asphalt Inc., and Mountain Home Materials delivered or caused to be delivered their bids at the time and place appointed in the bid notice.
 4. At 9:00 a.m. on the 18th day of February, 2026, said bids were opened and publicly read in the office of the County Judge. Atlas Asphalt Inc. submitted a bid as shown by Exhibit C and Mountain Home Materials submitted a bid as shown by Exhibit D.
 5. It was determined to be in the best interest of Baxter County to accept the bids submitted by both Atlas Asphalt Inc. and Mountain Home Materials. Said acceptance to Atlas Asphalt Inc. is hereto attached as Exhibit E and said acceptance to Mountain Home Materials is hereto attached as Exhibit F.
- IT IS THEREFORE the order of this Court that the bids from Atlas Asphalt Inc. and Mountain Home Materials are hereby accepted. The Clerk of this Court shall docket this copy and cause a copy of this order and supporting documents to remain on file for public inspection.

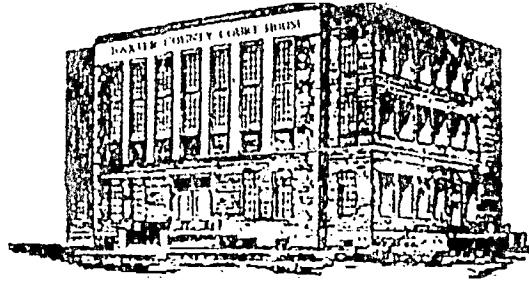

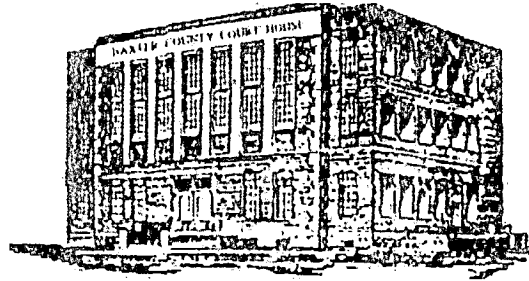

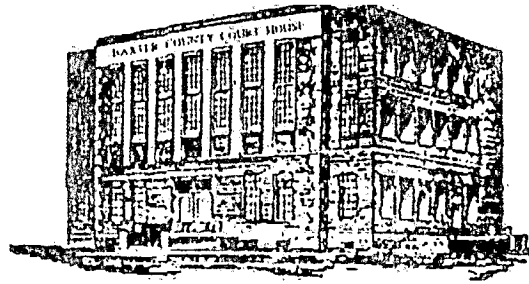
