


PETITION

AGREEMENT FOR TEMPORARY LOAN OF PROPERTY

This Agreement is made and entered into by and between the Sheriff of Baxter County, Arkansas and the Sheriff of Johnson County, Arkansas.

That for and in consideration of mutual aid, benefit, and cooperation between the law enforcement agencies specified herein, the Sheriff of Baxter County hereby agrees to the temporary loan of property currently in his legal possession and under his care, custody, and control to the Sheriff of Johnson County, to-wit:

Fiberglass Airboat, Serial No. NM120317  
Baxter County Inventory Control No. 2553

That the Sheriff of Johnson County hereby agrees to take temporary possession and control of said boat as specified and described hereinabove, and agrees to be responsible for and provide for the general maintenance of the boat as well as provide insurance coverage thereon during the term of this agreement.

That this agreement shall be in effect for six (6) months from the date hereof, and will expire on February 28, 2007.

That upon the expiration of this agreement, the Sheriff of Johnson County shall return said boat to the Sheriff of Baxter County.
