ORDINANCE NO. 2022 –

**BE IT ENACTED BY THE QUORUM COURT OF BAXTER COUNTY, STATE OF ARKANSAS,
AN ORDINANCE TO BE ENTITLED:**

**AN ORDINANCE ADOPTING A NEW PERSONNEL POLICY MANUAL FOR BAXTER
COUNTY EMPLOYEES.**

WHEREAS, it has been determined by the Baxter County Courts Personnel Committee that changes, additions and new upgrades in the Baxter County Personnel Policy manual are necessary to improve the overall effectiveness and efficiency of the Baxter County Government; and

WHEREAS, it is the desire of Baxter County Personnel Committee that proper evidence has been provided by the Human Resources Department of Baxter County, and input from all elected officials and department heads to upgrade said policy; and

WHEREAS, Baxter County has been provided evidence authorized by the Court, to update and revise the Social Media Policy #200.08, FOIA #200.09, Background Investigations #300.03, Rehire Eligibility and Service Recognition #300.04, Donation of Paid Leave #500.06, FMLA Leave #500.07, Military Leave #500.09, County Grievance Committee #700.02, Timely Grievance Hearing Request Required #700.03, and Back Pay Provisions when an Employment Decision is Reversed #700.04 within the Personnel Policy for Baxter County employees; so

**NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BAXTER
COUNTY, ARKANSAS, THAT:**

Section 1. The Baxter County Quorum Court hereby approves the updates and revisions to the Social Media Policy, FOIA, Background Investigations, Rehire Eligibility and Service Recognition, Donation of Paid Leave, FMLA Leave, Military Leave, County Grievance Committee, Timely Grievance Hearing Request Required, and Back Pay Provisions when an Employment Decision is Reversed within the Baxter County Personnel Policy and are hereby approved and implemented.

Section 2. If any provision or section of this Ordinance is held invalid by a court of competent jurisdiction, such invalidity shall not affect other provisions and sections on the Ordinance and shall be severable.

Section 3. This Ordinance is to be codified in the Baxter County Code of Ordinances, §240.00, paragraphs (1) and (2) and supersedes all previous Personnel Policies coded therein.

Section 4. This Ordinance being necessary for the preservation of public peace, health, and safety, an emergency is hereby declared. This Ordinance shall be in full force and in effect from and after the date of its approval and passage.

**AN ORDINANCE TRANSFERRING AND APPROPRIATING FUNDS
INTO THE ARPA REVENUE REPLACEMENT FUND #1006 FROM
FUND #3046 AMERICAN RESCUE PLAN, FOR A ONE-TIME LUMP
SUM PAYMENT TO ELECTED OFFICIALS.**

WHEREAS, the Quorum Court of Baxter County, AR, recognizes the need to provide resilience to our local government and acknowledges a need to provide a one-time lump sum payment for hours worked during the calendar year 2021, to the County elected officials as authorized by the American Rescue Plan and guidance by the United States Treasury; and

**NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BAXTER
COUNTY, ARKANSAS,**

SECTION 1. That it hereby approves a one-time lump sum payment for elected officials for the period of January 1, 2021 to December 31, 2021.

SECTION 2. Each elected official of Baxter County shall be provided the additional payment of \$5,115.55 with deductions as required by 31 CFR Part 35 the US Treasury Interim Final Rule, from which all applicable payroll deductions shall be deducted.

SECTION 3. The Baxter County Treasurer is hereby authorized to transfer \$35,808.85 from American Rescue Plan Fund #3046 to ARPA Revenue Replacement Fund #1006.
