AN ORDINANCE RE-APPROPRIATING FUNDS IN THE AMOUNT OF \$7,000.00 FROM (#3046) ARPA FUND TO (#1006) ARPA REVENUE REPLACEMENT FUND TO PAY FOR 2021 YEAR FEDERAL AUDIT (ACEE).

**ARTICLE 1.** The original budget to pay for the Federal Audit was set up in Fund (#3046). This was before the "Final Rule" that was released in early 2022, which removed some of the restrictions on the spending of ARPA Funds.

**ARTICLE 2.** The Federal Audit (ACEE), has recently been completed and the need to move the appropriation from the previous Fund of (#3046) to Fund (#1006) is needed to complete the payment of the invoice. The revenue from Fund (#3046) has already been moved to Fund (#1006) previously by Ordinance# 2022-14.

**ARTICLE 3.** There was an ordinance done previously to pay for the Audit out of Fund (#1005) Coronavirus Relief Fund, Ordinance #2022-18, but Fund (#1005) does not have sufficient balance to cover the expense of the Federal Audit.
