ORDINANCE NO. 2023 -

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BAXTER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING ORDINANCE NO. 2023-42: (AN ORDINANCE ESTABLISHING COMPENSATION TO BE PAID TO BAXTER COUNTY ELECTION OFFICIALS) TO INCLUDE REIMBURSEMENT FOR STATE MANDATED TRAINING.

Article 1: <u>Affirmation</u> The Baxter County Quorum Court finds it necessary to increase the compensation to be paid to Baxter County Election Officials in the performance of their duties in the service of Baxter County. Per ACA §7-4-112, this compensation is to be paid to the Election Officials in their duties related to the coordination of elections.

<u>Section 1.</u> RATES OF COMPENSATION. Baxter County Election Poll Workers shall be paid \$15.00 per hour for their duties related to holding an election.

<u>Section 2.</u> Baxter County Election Poll Judges shall be paid \$16.00 per hour for their duties related to holding an election.

<u>Section 3.</u> Members of the Baxter County Election Commission shall be paid a sum of \$125.00 per diem for their participation in any public meetings. The Election Commissioners shall be paid \$18.00 per hour for work done outside of a public meeting for their duties related to the coordination of elections. When a Baxter County Election Official attends training mandated by the State, they will be reimbursed at the amount established by the State Board of Election Commission for that training.

<u>Section 4.</u> MILEAGE REIMBURSEMENT. Any Election Official using a personal vehicle for official election business shall be allowed mileage compensation at the current county travel reimbursement rate.

<u>Section 5.</u> CONFLICTING ORDINANCES REPEALED. This Ordinance supersedes Baxter County Ordinance No. 2020-6; and any and all other ordinances that may be in conflict.

<u>Section 6.</u> CODIFICATION. This Ordinance shall be codified in the Baxter County Code of Ordinances and the sections may be renumbered and re-lettered to accomplish such intention.

<u>Section 7.</u> SEVERIBILITY CLAUSE. If any part of this Ordinance is found invalid, the remaining shall remain in effect.

Article 2: <u>Effective Date</u> This ordinance shall be effective immediately upon its passage and approval by the Quorum Court.

Article 1: <u>Affirmation</u> the Baxter County Election Commission and Baxter County Clerk have established a new Vote Center to take the place of two current vote centers for early voting and election day starting in the Primary Election of 2024. An ordinance to establish Vote Centers was passed in 2018.

<u>Section 1.</u> First United Methodist Church will take the place of the Baxter County Courthouse and the Baxter County Election Commission Headquarters for Early Voting and Election Day Voting.

Section 2. The Courthouse and Election Commissioner Headquarters will be held for backup Vote Centers if needed.

Section 3. CONFLICTING ORDINANCE REPEALED. This Ordinance superseded Baxter County Ordinance No. 2018-33; and any and all other ordinances that may be in conflict.
