A RESOLUTION OUTLINING THE PARAMETERS OF THE FUNDING FOR ECONOMIC DEVELOPMENT CAPITAL PROJECTS BY THE BAXTER COUNTY ECONOMIC DEVELOPMENT COMMITTEE.

# BE IT RESOLVED BY THE QUORUM COURT OF BAXTER COUNTY, ARKANSAS, THAT:

<u>Section 1.</u> The following parameters will be set as a safeguard for requests made to the Economic Development Committee for funding Economic Development Capital Projects:

- 1. Provide evidence of a solid business plan
- 2. Provide evidence that Individual/Organization is in good standing with Baxter County and the State of Arkansas
- 3. Proof of financial backing to see project through to fruition
- 4. An estimate of the number of jobs the project will create
- 5. A valid estimate of a positive Return on Investment for Baxter County
- 6. The Economic Development Committee has final discretions to approve or deny projects
- 7. The Economic Development Committee will send all approved projects to the full Quorum Court for approval

<u>Section 2.</u> Requests for distributions from the Economic Development Capital Projects Fund (4800) - County Special Projects must be in accordance with Amendment 97 and contribute significantly to the local economy by supporting infrastructure development, long-term economic growth, and job creation. Funds can be used for, but not limited to, site preparation (such as tree clearing, dirt work, demolition/removal of existing structures) and workforce development. Funds cannot be used for buildings.

<u>Section 3.</u> This resolution shall be in full force and effect from and after its passage and approval.
