The Baxter County Quorum Court met in regular session at 5:30 PM in the Baxter County Courtroom with County Judge Kevin Litty presiding. Members present were: Maryanne Edge, Dennis Frank, Eddie Griffin, Lisa House, Mike McDonald, Bob Nault, Eric Payne, Rick Steiner, Dirk Waldrop and Shannon Walker. Justice Cameron Davis was not in attendance. The meeting began with a moment of silence and the Pledge of Allegiance.

Judge Litty asked if there were any additions or corrections to the minutes of the August meeting. Justice House moved that the minutes be approved as submitted. Justice Edge seconded the motion. All voted in favor.

County Treasurer Jenay Mize provided the Court with a Treasurer's report.

Justice Frank reported on the August 19th Budget Committee meetings.

Justice Nault reported on the September 2nd Environmental Committee meeting.

Appropriation Ordinance #2025-41, AN ORDINANCE APPROPRIATING FEES AND REIMBURSEMENTS IN THE AMOUNT OF \$23,512.46 RECEIVED IN THE MONTH OF JULY TO THE SHERIFF'S OFFICE 2025 BUDGET, was sponsored by Justice Edge and read by title only by the Chief Deputy Clerk. Justice McDonald moved to adopt the ordinance, seconded by Justice Edge. Being no discussion, the roll was called. Voting YEA: Justices Edge, Frank, Griffin, House, McDonald, Nault, Payne, Steiner, Waldrop and Walker. The motion passed and Appropriation Ordinance #2025-41 was adopted with a vote of 10 YEA, 0 NAY.

Appropriation Ordinance #2025-42, AN ORDINANCE APPROPRIATING FUNDS IN THE AMOUNT OF \$2,508.50 FROM COUNTY GENERAL FUND (1000) INTO JUVENILE SERVICES 2025 BUDGET, was sponsored by Justice Griffin and read by title only by the Chief Deputy Clerk. Justice Griffin moved to adopt the ordinance, seconded by Justice Edge. Being no discussion, the roll was called. Voting YEA: Justices Frank, Griffin, House, McDonald, Nault, Payne, Steiner, Waldrop, Walker and Edge. The motion passed and Appropriation Ordinance #2025-42 was adopted with a vote of 10 YEA, 0 NAY.

Ordinance #2025-43, AN ORDINANCE TO AMEND ORDINANCE NO. 2022-11: "AN ORDINANCE TO ESTABLISH AN EMPLOYEE LIABILITY FUND"; AND TO AUTHORIZE THE COUNTY TREASURER TO REPLENISH THE EMPLOYEE LIABILITY FUND AS NEEDED, was sponsored by the Budget Committee and read by title only by the Chief Deputy Clerk. Justice Edge moved to adopt the ordinance, seconded by Justice Walker. After a brief overview from Judge Litty and Justice Frank, the roll was called. Voting YEA: Justices Griffin, House, McDonald, Nault, Payne, Steiner, Waldrop, Walker, Edge and Frank. The motion passed and Ordinance #2025-43 was adopted with a vote of 10 YEA, 0 NAY.

Ordinance #2025-44, AN ORDINANCE TO ESTABLISH THE ESCHEATED ESTATE TRUST FUND ON THE BOOKS OF BAXTER COUNTY, ARKANSAS; FOR OPERATION OF SAID FUND; AND TO DECLARE AN EMERGENCY, was sponsored by the Justice Griffin and read by title only by the Chief Deputy Clerk. Justice Griffin moved to adopt the ordinance, seconded by Justice Edge. After a brief overview from Treasurer Mize, the roll was called. Voting YEA: Justices House, McDonald, Nault, Payne, Steiner, Waldrop, Walker, Edge, Frank and Griffin. The motion passed and Appropriation Ordinance #2025-44 was adopted with a vote of 10 YEA, 0 NAY.

Ordinance #2025-45, AN ORDINANCE TO ESTABLISH A CORONER'S BUILDING FUND AND AN ANNEX BUILING FUND; AND TO DECLARE AN EMERGENCY, was sponsored by Justice Edge and read by title only by the Chief Deputy Clerk. Justice Edge moved to adopt the ordinance, seconded by Justice Walker. Being no discussion, the roll was called. Voting YEA: Justices McDonald, Nault, Payne, Steiner, Waldrop, Walker, Edge, Frank, Griffin and House. The motion passed and Ordinance #2025-45 was adopted with a vote of 10 YEA, 0 NAY.

Re-appropriation Ordinance #2025-46, AN ORDINANCE RE-APPROPRIATING FUNDS IN THE AMOUNT OF \$75,000.00 FROM COUNTY GENERAL TO THE CORONER'S BUILDING FUND 2025 BUDGET, was sponsored by Justice Davis and read by title only by the Chief Deputy Clerk. Justice House moved to adopt the ordinance, seconded by Justice Edge. Being no discussion, the roll

was called. Voting YEA: Justices Nault, Payne, Steiner, Waldrop, Walker, Edge, Frank, Griffin, House and McDonald. The motion passed and Re-appropriation Ordinance #2025-46 was adopted with a vote of 10 YEA, 0 NAY.

Resolution #2025-23, A RESOLUTION TO GRANT A CONSERVATION EASMENT TO THE ARKANSAS HISTORIC PRESERVATION PROGRAM FOR THE CASEY HOUSE, was sponsored by Justice Davis and read in its entirety by the Chief Deputy Clerk. Justice Edge moved to adopt the resolution, seconded by Justice House. Being no discussion, the roll was called. Voting YEA: Justices Payne, Steiner, Waldrop, Walker, Edge, Frank, Griffin, House, McDonald and Nault. The motion passed and Resolution #2025-23 was adopted with a vote of 10 YEA, 0 NAY.

Resolution #2025-24, A RESOLUTION CONFIRMING THE APPOINTMENT OF WILLIAM HARDAKISS BY THE COUNTY JUDGE TO THE MIDWAY FIRE PROTECTION DISTRICT BOARD OF COMMISSIONERS, was sponsored by Justices Frank and House and read in its entirety by the Chief Deputy Clerk. Justice Nault moved to adopt the resolution, seconded by Justice Edge. Being no discussion, the roll was called. Voting YEA: Justices Steiner, Waldrop, Walker, Edge, Frank, Griffin, House, McDonald, Nault and Payne. The motion passed and Resolution #2025-24 was adopted with a vote of 10 YEA, 0 NAY.

The meeting was called to order at 3:30 pm by Chairman Dennis Frank and a quorum was declared with all members present.

<u>Minutes</u> – A motion was made by Maryanne Edge to approve the minutes from the June 12, 2025 meeting as written, with a second from Shannon Walker. All were in favor and the minutes were approved unanimously.

2026 Preliminary Budget Requests — Chairman Dennis Frank brought up discussion on the Employee Liability Fund needing to be funded regularly since the initial \$1,000,000.00 set up in 2022 currently has a balance of \$264,000.00. After lengthy discussion, Cameron Davis made a motion to amend ordinance 2022-11 establishing an Employee Liability Fund to give the Treasurer the authority to replenish the Employee Liability Fund as needed to maintain a \$500,000.00 balance, with a second from Shannon Walker. All were in favor and the motion passed unanimously. Judge Litty shared with the Budget Committee his intention to begin the process of building a county annex building. David Stults gave an update on the cost to upgrade the tornado sirens but is still waiting on more information to complete the cost estimate.
